The **SD Child Identification Program** (SDCHIP) addresses the alarming fact that over 1,000,000 children are reported missing in the United States each year, or one every 43 seconds.

The SD Masonic CHIP kit is the most comprehensive service of its kind anywhere. SDCHIP is provided at no charge to the public and all of the identifying items generated during SDCHIP are given to the child's family.



The **Masonic Model Student Assistance Training Program** (MMSATP) is an intensive 3 day training workshop for teachers to learn how to identify, intervene with and create appropriate referrals for students that may be at risk for substance abuse, depression, suicide or violence.
